The latest we have heard is that the RMS have appointed an "expert Facilitator "(unnamed) and the work of the Focus Groups is suspended until the facilitator commences work at the RMS. We have also received a 23 Question survey to the Club from the RMS (the previous survey last month was from CHMC), revolving

around the operation of the Log Book Scheme. Keith read the questions to the meeting and after discussion the Secretary moved that the Committee be empowered to handle the submission on behalf of the Club. Seconded David Toy. Carried. Members indicated that they were in favour of continuing the Scheme. Keith said that the CHMC is concerned about the abuses of the Scheme and gave some examples. We hope to convey our concerns via the questionnaire. President added that any member should forward any concerns to a Committee member promptly as the closing date for the submission is 27 June 2019.

Wilga Coutts presented a proposal for the Club to sponsor a National Trust Historic Houses Tour for pre1931 vehicles, centred in the Southern Highlands at Retford Park. Naming a new publication in the historic vehicle movement isn't easy as almost all our Clubs have an established newsletter or magazine of their own, and all those usually have a catchy title that befits the hobby and/or the club. The "Good Oil" was originally selected but it was pointed out that this was the long-standing title of the journal of one of our Clubs. To avoid any confusion Council has re-named its new bulletin "Dinkum Oil" which is a name with a good historical pedigree and blends our Bush background with our automotive interests.

The historical link - The original "Dinkum Oil" newsletter was a WW1 Australian trench publication of eight issues pointing out the absurdity of life at Gallipoli and written by Australian war correspondent Charles Bean and Sergeant Frank Noonan in 1915. Major Thomas Blamey had requested the production of a newsletter that would dispel rumours and spy-mania so the title "Dinkum Oil" was particularly appropriate as it was a slang term in WW1 meaning 'true news'.

I suppose it could have been much worse if the brakes had failed coming down the Blue Mountains.

Memorandum of Understanding HVS	Regulatory Policy to consider whether a review of the Historic Vehicle Scheme and potential introduction of a Memorandum of Understanding for the Historic Vehicle Scheme would be feasible in the future after the Classic Vehicle Log Book trial has been reviewed. The Classic Vehicle Log Book trial is due to end on 30 September 2019.
Trailer Paper	When considering whether a trailer meets the eligibility requirements for the HVS, customers should refer to the current policy which applies to any vehicle seeking registration under the HVS. Use of HVS vehicles for Point-to-point. Has it been clarified if this is permitted or if the website needs rewording? 42 validity of Vehicle Inspection Reports -When will FAQs and website entries clearly reflect this policy?

The validity period for a light vehicle safety check is 6 months. Information can be located on the RMS website here:

https://www.rms.nsw.gov.au/roads/registration/inspections/index.html The safety check is required if the club approving the Historic Vehicle Scheme application is less than two years old.

Communications will be circulated to industry shortly to re-iterate these guidelines.

Historic Vehicle Registration Plates what will be the next letter after H (noting that plates are currently being issued well into the 90000 range)? We have submitted a request internally to ascertain whether the original 20,000 plate numbers can be utilised.

RMS is investigating options for plate numbers once they reach 99,999. We can assure you that plates will still be issued to Historic Vehicles at this time. It has since been confirmed that the next plate sequence will be J.

Data Base Issues club details are not showing on registration check searches. Are these not being entered by Services NSW staff in the required text field or is the data base not responding correctly? Service NSW procedure requires the car club approving the conditional registration to be listed at the time of registration. We will work with Service NSW to ensure staff are aware of this procedure and recording car club information correctly. We will also investigate internally to rectify any HVS registrations not listing the appropriate car club.

Recognised Club Membership - Is it a requirement that membership remain current throughout the HVS registration period or only at the date of initiation or renewal? No, this is because a member may be moving between clubs, not using the vehicle for a period of time or temporarily overseas. RMS does not have a system to identify when car club memberships lapses. It is the responsibility of the registered operator to ensure they meet conditions of registration at all times. Once the car club membership lapses, the owner/driver may be in breach of conditions of registration if the vehicle is used.

Conditions for HVS registration are listed on the RMS website: https://www.rms.nsw.gov.au/roads/registration/get-nsw-registration/historic-vehicles/index.html

Historic vehicles under the historic vehicle scheme may be operated on roads and road-related areas only under the following conditions:

- 'Registered operator must be a member of an authorised motoring club'
- 'Use only in conjunction with an authorised club event or maintenance'.

Draft Guides on how to register vehicles under CVS and HVS - promised by Tristan O'Donnell on 18 March 2018. Has there been any progress or were the September 2018 documents issued without further consultation as promised?	We will develop communications for distribution via your newsletter and other channels to remind all car owners and car clubs of the conditions of registration and the importance of ensuring club membership is valid at all times. It is recommended that car clubs implement a process internally for notifying members when their membership is close to lapsing (e.g. 6 weeks out). List of HVS vehicle registration details linked to each primary club be provided to them. Any feedback?	The sharing of this information could be considered a breach of Privacy. Clear process for updating club contact details / signatories for section 4 and 5 of the 1259 Historic Vehicle Declarations.	Car clubs are encouraged to keep their club contact details and list of approved signatories up to date. Please email ais@rms.nsw.gov.au and provide the full name of the car club, contact details, and any relevant updates.

The number of clubs becoming RMS Approved for HVS is causing concern as the process of approval is a desk audit of information provided without any reference to peak bodies (CHMC / CMC / SMA) who have on the ground knowledge or meetings with club officials prior to approval. How can HVS be renewed by telephone when Services NSW centres insist on original documentation?	Car owners can renew their Historic Vehicle Registration via a Service Centre, or by phone or email. The customer will be asked to email or fax original documentation through to Service NSW for processing. Does the provision to renew registration three months in advance apply to HVS / CVS?	Yes. Conditional registration can be renewed up to three months in advance by visiting a Service NSW branch. We require a new Historic Vehicle Declaration to be completed by the car owner at the time of renewal.
Has there been any progress on a combined meeting with CHMC / CMC / SMA in early May?	Yes. As discussed in the RMS/CHMC working group, the working group has now been opened to Australian Confederation of Motor Clubs (ACMC). The meeting is scheduled for Tuesday 7 May 2019. The agenda will be distributed mid-April after consultation and feedback for agenda items. The meeting has now been scheduled for 29 th May in Parramatta.
Review content for mass limit for H plate trailers and confirm with industry whether it is still 75%?	Historic vehicles must meeting the load restraint guidelines listed on the RMS website: https://www.rms.nsw.gov.au/roads/registration/get-nsw-registration/historic-vehicles/index.html Currently the load restraint limit is the same as a regular vehicle. The requirement of "maximum load allowed is two thirds of the manufacturer's load limit" was removed in July 2016.
Vehicle Safety Inspections for LPG fuelled vehicles on HVS	The current policy only requires the following to renew a vehicle under the HVS: http://www.rms.nsw.gov.au/roads/registration/get-nsw-registration/historic-vehicles/index.html#Vehiclesuitabilityforsafeuse Vehicle suitability for safe use Historic vehicles must be declared suitable for safe use by:

- A vehicle safety check inspection report, or
- An Historic Vehicle Declaration not greater than 42 days old Note: A vehicle safety inspection report must be presented if the club is less than two years old
- For historic plant vehicles, a Vehicle Suitable for Safe Use Declaration must be presented.

Not all clubs will require a customer to obtain a Safety Check Inspection and could rely on club declaration.


