There is also considerable cost saving as our only commitment is our minimal rent. It is true that with this site we would have to find an alternative to hold a large Rally It is not my role to influence your vote in any way. As president, my duty is only to ask you to give serious consideration to the future of our club. As another President once almost said "ask not what your club can do for you ask what you can do for your club."

### Letters and emails received regarding the new club house issue

Dear Mr Secretary,

Thanks for giving me a report on the meeting last night.

It was unfortunate that I could not attend as I have been in Isolation for the past week.

If I was there, I would have spoken in favour of the Lucknow School and it would be appreciated if this could be forwarded to the members.

A little background on me, for those who are unsure. I currently manage all aspects of a large industrial and office site for a national company.

I was also the Hall Lettings Officer for the Veteran Car Club rooms in Sydney for 5 years. Plenty of Car Clubs rented our rooms from us. I often envied their position – they just paid the rent, I had to organise everything else.

After reading the reports on the prospective Clubrooms, I decided to do a drive past the main two sites (Lucknow School and Old Trotting Track).

In my opinion, the Lucknow School would be the preferred option. My reasoning, is that it makes more sense from a business angle.

The Trotting track, as we do not have a quote, is financially unknown. We know we will need to supply Maintenance, Gas, Electricity and do we also pay for water?? There was mention of the back to base alarm. Will we need to pay for that service? Do we know what the call-out fee is for the alarm? Currently, I am signing invoices for \$98+GST per event for my work. However, the school is financially known. Council have supplied a quote of the rental being approx. \$600 per year, inclusive of Gas, Electricity and Water. Council will also provide maintenance for the site.

One of the main considerations business has today is "What are the Liabilities?" Lucknow School will be rented from the Orange City Council. They are required by Work Health and Safety legislation to ensure the room is in appropriate condition to rent.

However, at the Trotting track, if the club is maintaining the rooms and the grounds, we are then bound by this legislation. In this case, there are some very serious questions that need to be asked to ensure the club is not liable for:

- Breach of Legislation (or Public Health Orders) Is the club capable (or willing) to clean the rooms to a suitable condition (including deep cleaning if that is reintroduced)?
- Increased exposure for Public Liability If we are maintaining the grounds, who is liable if someone trips on the grass? Does our Volunteer Insurance give us enough cover?
- Increased risk of Malicious Damage Who is liable for Break-ins, Grounds Vandalism, etc.?

Will there be a rental agreement for either premise? A rental agreement from Council would be pretty simple – We pay our rental; they supply the rooms. And I would expect there would be Fixed Term with options of renewing.

However, with the Trotting track, it has the possibility of being very convoluted, who pays for what? What is covered? What happens if the building and grounds are not maintained to Kart Club expectations? Are we going to be subjected to a new agreement with each new Kart Club Committee? Could we to find ourselves evicted in 12 months' time? Could we find ourselves paying substantially more rent?

For all these reasons and more, the Trotting track poses too much of a risk when compared to the Lucknow School.

Also, and let's be honest with ourselves - wouldn't we (and our partners) prefer indoor toilets to ones that are outside in the paddock??

Euan also added some thoughts he had that I have included here due to space restriction in the newsletter.

I had also forgotten that the trotting track has a back to base alarm system. The installation of this alarm should give us the clue that there has been trouble at the site in the past and I can't believe that the call out fee would be any less for us. Council have indicated that the call out fee was our responsibility

Hi Members,

Most of you will now have received your voting envelopes on the decision of our next meeting premises.

Whichever way the matter is decided a section of Club members will be disappointed, please respect their opinions. A decision has to be made and only time will tell whether we have made the correct move. Your vote does count. We urge you to vote as experience has shown that often only 50% of Club members actually cast a vote.

We have had questions from a number of members who have been unable to attend the last few Club Meetings about the Costs and Occupancy conditions of the two sites under consideration, as they feel that they are voting for the unknown. We have an outline of terms and conditions from both the sites but to get the firm arrangements under way we have to decide on one site or another. The vote is mainly to decide by our members which site they would prefer so that we can proceed to firm arrangements.

There are pros and cons for both sites which are listed in the March edition of the Restoration Rambler.

### Harness Club Members' Room.

The Orange Kart Club hold the lease from the Orange Council and we would be a sub-lessee; We have begun negotiations with the Kart Club. It may be possible to negotiate a lease direct from the Council.

The Kart Club indicated that other Clubs and themselves would like use the Room for occasional training days and the like but with 2weeks notice to us.

Our Club would be responsible for Gas, Electricity and water.

The Kart Club have indicated that if we are prepared to maintain the large outside area with grass cutting and cleaning the Room and toilets, rent would be nil.

There will be some outlay by our Club for the initial set up as the building has been unoccupied. There are some other occupancy matters but it is felt these can be addressed satisfactorily when we negotiate further to the Kart Club.

We would have to maintain our Public Risk Insurance and a contents policy

### The Lucknow School, a Community Hall.

We would be on a permanent booking basis from the Orange Council, for one of the two rooms at the school. This will to cover Ladies Day and our Meeting nights.

We would have the option to make a booking for the whole building, for say, a social function.

We have the use of the attached parking area.

An initial period of two years with options has been suggested.

The going charge by Council to Non-Profit groups is \$10 per hour and we estimate that our charge would be under \$1000 per year.

Council pays Gas, Water, electricity, maintenance and cleaning. We would save by not having to pay these charges as we do at Bloomfield.

Occasionally the whole of the building is rented by Council to other groups for functions and these would be using our area.

We would have to maintain our Public Risk Insurance and some smaller contents Insurance,

Subject: Car Club meeting Summary

Hi Euan and The Orange Vintage Car Club,

Thanks for meeting us on site last week, I look forward to another inspection tomorrow 1/3/2022. Below are some points for discussion, while we are negotiable on some we would prefer if we can come to a mutually beneficial arrangement between both OKC and the Vintage Car Club to make this work.

I've had a chat to our committee and we all believe this could be a mutually beneficial relationship. Some points our club would like to ensure are raised prior to confirming the relationship

- 1. OKC intends to use the clubhouse for race functions up to 6 times per year. These are usually either Friday or Saturday afternoon/evenings
- 2. OKC will leave the clubhouse clean following each event
- 3. OKC has a relationship with a local training group as well as other functions that would see the leasing facility 1-2 days per time up to 15 times per year. This is a source of income for our club and we would really like to continue this arrangement. We are happy to agree that we will not lease the facility for high-risk evening parties such as 18ths or 21<sup>st</sup> where alcohol is involved. As a small club this financial arrangement works well, we are not against looking at other ways we can make money on the side if the vintage car club can think of any ideas?
- 4. OKC can provide the Vintage car club a minimum 2 week's notice of intended functions/training days

Would the vintage car club be interested in helping OKC on our race days or in canteen etc? no pressure at all we may also be able to help you out if required?

Vintage car club will be responsible for the following

- 1.Gas system compliance and gas supply into building (OKC does not want to use Gas, it is recommended Vintage Car Club arrange locks for gas bottles so they cannot be turned on whilst not in use)
- 2. Electricity supply our treasurer is chatting to power company to see if a separate bill can be arranged – OKC happy to cover cost of electricity when we have a function or training onsite.
- 3.Grounds maintenance, OKC would like to come to an arrangement where instead of a monetary lease, the grounds around the clubhouse and toilets could be maintained by the vintage car club.
- 4.I also note:

- it was raised regarding the use of the sheds, OKC is happy to provide 100% exclusive lease of any shed on our lease that is currently not being used. It will be up to Vintage Car club to secure and maintain the sheds.
- It was raised there is currently no disabled toilets on site. OKC would be happy to work with the vintage Car club in applying for grant funding for disabled toilets and showers and other improvements to the site
- OKC would like to work with Vintage car club and other users of the facility to improve internal fixtures such as seating/tables, cooking and catering equipment.
- OKC would like to work with vintage Car Club to hold events together in hope of making both clubs stronger
- Both parties could come to an arrangement on carpet cleaning every 12 months.
- If we can come to agreeance on the above points, I think we should enter into a short term arrangement for up to 6 months just to be sure it's a good fit for both parties. Then we can fine tune details and have a proper lease arrangement drawn up.
- OKC has a long term plan (that may never go ahead) of shifting our IN/OUT grid adjacent to the clubhouse, if and when this occurs this may see an increased use of the facility also
- OKC has another plan (not yet investigated or planned) of developing a Dirt Kart track near the clubhouse this may se an increased use of the facility
- Canobolas motor cycle club have been pushing to lease the harness club grounds from council, OKC has had some positive and not so positive dealings with this club in the last 12 months. While we would like to see the harness track used in a motorsport capacity OKC has not come to an arrangement with CMCC to share the clubhouse or toilet facilities however I thought I would make you aware they are sniffing around
